Michael is also a qualified valuator, being a member of RICS. He is therefore also well versed in the accounting issues that may arise in a dispute, such as post-acquisition purchase price adjustments and qualified to give expert opinions also on issues relating to valuation, such as quantum of damages. In addition, as a certified fraud examiner (CFE), he has conducted numerous investigations and has testified on issues such as bribery and corruption.

Over the course of a career spanning more than 20 years, Michael has been involved in a wide variety of cases covering many industries. However, a great deal of his work has involved bilateral investment treaty (BIT) claims, acting either for the state or on behalf of investors, and claims revolving around the energy sector, such as pricing disputes. He has testified under the majority of the arbitration institutional rules (including ICC, ICISD, LCIA, SCC and UNCITRAL) as well as before many of the jurisdictional courts where he has worked. His experience includes cases involving the electricity, oil and gas, telecommunications, pharmaceuticals, information technology, manufacturing, financial services, health care, construction, agriculture, infrastructure, and travel sectors.

Since 2006, Michael has been responsible for KPMG's dispute advisory practice covering Albania, Belarus, Bosnia and Herzegovina, Bulgaria, Croatia, Czech Republic, Estonia, Hungary, Kosovo, Latvia, Lithuania, Macedonia, Moldova, Montenegro, Poland, Romania, Serbia, Slovakia, and Slovenia (Central and Eastern Europe). Prior to that he worked in KPMG's UK and Canada practices. He also established KPMG's forensic practice covering the English speaking Caribbean, Mediterranean and English Channel.
