Total value of project was of 84.7 million USD, the equivalent in RON. The specific objectives were reaching the following performances: extending the life of the energy block no. 3 by 100.000 hours, reaching and exceeding project parameters, obtaining a minimum availability of 85% with a capacity factor of 80%, compliance with the environment conditions. The works were executed under FIDIC contractual conditions.

Among the performed activities, Mrs. Alina Cobuz coordinated the legal actions for claims analysis, participated in negotiations, within the dispute resolution procedure (DAB) initiated in the project. Mrs. Cobuz acted as legal representative and contractual claims expert in the arbitration cases no. 14.079/FM and no. 16.997/FM held in Zurich Arbitration Court.

The two cases were won through transaction.
